



Paramount Ice has developed protocols in conjunction with provincial regulations in order to keep our customers and staff safe during our re-opening process.

Please read and adhere to the following protocols before entering the facility. Thank you!

- Rentals may not exceed 10 people inside each arena. NO EXCEPTIONS!
- Dressing rooms are not permitted.
- Physical distancing must always be maintained in the facility and on the ice. Players and trainers must remain a “stick length” away at all times. Contact drills and scrimmages will not be permitted.
- Participants will be granted entry to the rink a maximum of 10 minutes before their scheduled ice time and must exit the building immediately after their skate ends.
- Access to the lobby washrooms will only be permitted for urgent needs. Users must sanitize their hands outside the washroom before entering and wash their hands thoroughly after using the washroom.
- All whom enter the facility must wear a face mask. Players/ skaters may take the mask off when they enter onto the ice but must put the mask back on when their session is finished.
- After each skate there will be sanitation practices in effect to keep our customers and staff safe.
- All participants or parents/guardians must have scanned and signed our digital liability waiver before entering the facility.
- The office will not be open for public inquiry, if you have an immediate concern, we ask that you call our office line, and someone will assist you (416-551-5306).
- We ask that you use our driveway for drop offs and pick up when applicable.
- Spectators not permitted.
- No games and no scrimmages permitted.

## Liability Waiver for Access to Paramount Ice Facilities in Response to COVID-19

Please read this waiver in its entirety.

These conditions will affect your legal rights including the right to sue or claim for compensation should you contract COVID-19. We are currently permitting the public to access Paramount Ice facilities and make use of Paramount facilities if they sign the waiver below. This waiver must be signed and submitted by any persons who desire access to any Paramount Ice facilities before any use or access to Paramount Canada facilities is permitted. Individuals who have travelled outside of Canada within the previous 14 days or who are sick or who have been in contact with someone who is suspected of having COVID-19 must not access Paramount Ice arenas. This access may be withdrawn at any time based on health agency recommendations.

Parents or court-appointed legal guardians must be 18 years of age or older and must authorize on behalf of any participating minors and agree that they and the minors are subject to all the terms of this waiver as set forth herein.

The student applicant on the application/waiver and his/her parents/guardians agree that Paramount Sports Management/ Paramount Ice, shall not be held responsible for any injury, loss or damage whatsoever occurring to the participant while he/she is in attendance at Paramount programs or including while he/she is within the premises occupied by Paramount.

I/We consent to his/her or my attendance on the terms of this waiver of liability or in the case of a guardian of a person under 19 years of age grant our consent to the terms of this waiver. I/We acknowledge reading this Application/Waiver and Declaration and understand the conditions contained herein and agree to abide by all terms. All Participants understand and consent to their duty to wear the appropriate protective gear as it applies to their sport or profession.

I would like to access the Paramount Ice facilities and/or use Paramount Ice facilities. I am aware that Paramount Sports Management/ Paramount Ice and its staff cannot guarantee that I will not contract COVID-19 at Paramount Ice facilities. I am accessing and using Paramount Ice facilities at my own risk. In particular, I accept the risk of contracting COVID-19 should I attend Paramount Ice facilities.

**By signing and submitting this waiver, I am confirming the following self-assessment measures have been met:**

- I confirm that I have not travelled outside of Canada for the past 14 days.
- I have not been in contact with anyone who is suspected of having COVID-19 in the past 14 days.
- I have not been in close contact with anyone who has traveled within the last 14 days to any country outside of Canada.
- I have not experienced any cold or flu-like symptoms in the last 14 days (including fever, cough, sore throat, respiratory illness, difficulty breathing).
- I understand and confirm that no guests are permitted to accompany me at Paramount Ice facilities at this time.

By signing and submitting this waiver, I understand and consent to the conditions of this waiver and I consent to the use of my first name and last name that I have entered below as an adult and/or guardian to be used as an electronic signature in lieu of an original signature on paper. I understand that I have the right to request that I sign a paper copy instead. By checking here, I am waiving that right. After consent, I understand that I may, upon written request to Paramount Sports Management/ Paramount Ice, may obtain a paper copy of an electronic record. No fee will be charged for such copy and no special hardware or software is required to view it. I understand that my agreement to use an electronic signature with Paramount Sports Management for any documents will continue until such time as I notify Paramount Sports Management and in writing that I no longer wish to use an electronic signature. I understand that there is no penalty for withdrawing my consent. I understand that I should always make sure that Paramount Sports Management has my current email address in order to contact me regarding any changes if necessary.
